Dear Mr. Steinberg,

The NDEP has received and reviewed the Trust's above-identified Deliverable and finds that the document is acceptable with the following comments noted for the Administrative Record:

- 1. General comment, please note that the Site Management Plan referenced in this Deliverable has not yet been approved by the NDEP.
- 2. Approach for Identifying and Removing Areas of Visually-Impacted Soils, page 2, 1st full paragraph, if soil above the BCLs are not removed, then the impacted soil left in place will have to be documented in an Excavation Control Area.
- 3. Selection of Confirmation Soil Sample Locations, page 2, samples should be collected within the observed visually-impacted soils if still present. If the observed extent of the visually-impacted soil, has been removed, then sampling should occur within the range that the visually-impacted soil was observed.
- 4. Methods for Soil Sample Collection and Analysis, page 3, last paragraph of section, please check the proposed quality assurance/quality control sampling for consistency with the Quality Assurance Project Plan (dated May 26, 2009) that was approved by NDEP on June 1, 2009.

Please note that even though the Deliverable is marked "Draft", NDEP is approving the work proposed in the Deliverable with the above-listed comments and considers the Deliverable an approved final document.
