This monthly progress report fulfills requirements laid out in the April 12, 2005 Administrative Order On Consent (2005 AOC) between the State of Nevada, Department of Conservation and Natural Resources, Division of Environmental Protection (NDEP) and Tronox LLC (formerly Kerr-McGee Chemical LLC)..

Activities this month:

1. An internal Authorization for Expenditure (AFE) document has been signed by Tronox management, authorizing project funding.
2. Drawings describing the Effluent Clarity/AP-5 project have been submitted to Nadir Sous of NDEP for review. Flow Sheets, Piping and Instrumentation Diagrams and General Arrangement Drawings are included in the package.
3. A contract has been signed by Tronox LLC and Shaw Environmental Inc. covering engineering, procurement and construction of the new bioplant reactor, sand filter and AP-5 pond modifications necessary for the project. The \$3.5 million construction project is scheduled to be tied into the existing biological treatment plant in June of 2006.
