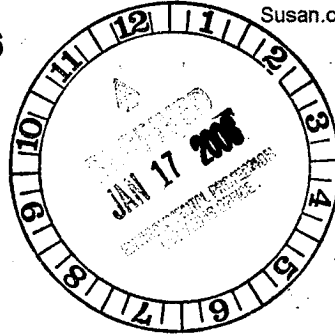

Subject: Tronox LLC ECA Quarterly Report – Fourth Quarter 2005

Pursuant to Section XIII of the Consent Agreement, signed September 5, 1996, between Nevada Division of Environmental Protection (NDEP) and Tronox LLC (Tronox), formerly Kerr-McGee Chemical LLC, Tronox submits the following quarterly status report for the Henderson facility's Environmental Conditions Assessment (ECA).

Activities Conducted, 10-1-05 to 12-31-05

Conceptual Site Model:

- October 14 – Tronox submits responses to NDEP September 6, 2005 comments on CSM.
- October 22 – NDEP comments on October 14 document
- November – Tronox receives water data on Las Vegas Wash.

Upgradient Investigation Work Plan:

- October 4 – Tronox submits Revised Table 6 to NDEP. NDEP provides verbal comments October 5
- October 5 – Tronox submits errata sheets to NDEP.
- October 6 – NDEP provides written comments on submittals for the Upgradient Investigation Workplan.
- October 7 – NDEP issued final meeting minutes
- October 14 – ECA Quarterly ECA Status report issued by Tronox
- November through December – Tronox works with MWH lab to define an expanded list of analytes (based upon the site-related chemical list), methods and detection limits added to Upgradient Investigation Work Plan.

Source Area Work Plan

- October 3, 2005 – NDEP concurs with Tronox's conceptual approach to the Source Area Work Plan, with conditions.
- October 21 – Tronox provides schedule for Source Area Phase A Work Plan
- November through December – Tronox works with MWH lab to define analytes (based upon the site-related chemical list), methods and detection limits needed for the Source Area Phase A Work Plan.


- October through December – Tronox developed and modified a Fact Sheet describing the ECA project and this undergoing internal review.
