The Nevada Environmental Response Trust (NERT) is pleased to present the Unit 4 and 5 Buildings Investigation Report for the first mobilization sampling event. This report summarizes the analytical results associated with the four soil borings that were advanced around the Unit 4 Building. NERT is currently ahead of schedule with the demolition of the Unit 4 Building cell floor and would greatly appreciate an expedited review of the Unit 4 and 5 Buildings Investigation Report. If possible, NERT would appreciate feedback from the Nevada Division of Environmental Protection by May 20, 2016. While this is an interim deliverable, NERT requires NDEP comment and/or concurrence on the attached due to the modifications this document proposes to the Unit 4 and 5 Buildings Investigation Work Plan previously approved by NDEP on April 13, 2015.
