Dear Ms. Lingenfelter:

Please find enclosed the 90 % Design Drawings for the IX Treatment System planned for incorporation into the Permitted Treatment Works at the Nevada Environmental Response Trust (NERT) site in Henderson, Nevada. Upon receipt of comments on the enclosed design drawings by the Nevada Division of Environmental Protection, Bureau of Water Pollution Control (NDEP, BWPC), NERT will submit the 100 % Design Drawings for final approval. Immediately upon receipt of NDEP, BWPC approval, Envirogen Technologies, Inc. (ETI) will begin construction of the IX Treatment System at Lift Station 1. Once operational, ETI will manage this system on behalf of NERT in accordance with the current and future National Pollutant Discharge Elimination System (NPDES) permits. The IX Treatment System is a critical component of NERT's plans to improve the management of the water level in GW-11. As such, NERT would greatly appreciate an expedited review of the design package.
