The Nevada Environmental Response Trust (NERT) is submitting the enclosed Site Management Plan Work Plan for soil removal activities associated with a leak from Interceptor Well Field Extraction Well I-S for Nevada Division of Environmental Protection (NDEP) review. This work plan is submitted in accordance with the Site Management Plan, Revision 6 to address a leak discovered by Envirogen Technologies, Inc. (ETI) on the discharge pipe to extraction well I-S. ETI detected the leak on October 25, 2021 at 7:10 am. The planned work is not within an excavation control area. NERT is also seeking NDEP's permission to complete the planned work as a Utility Project as defined in Section 4.6 of the Site Management Plan, Revision 6.
