This letter serves as the June 1, 2021 to May 31, 2022 Site Management Plan (SMP) Annual Report (Annual Report) for the Nevada Environmental Response Trust (NERT or the Trust) Site in Henderson, Nevada (the Site). As you are aware, the SMP was developed by the Trust at the request of the Nevada Division of Environmental Protection (NDEP). This Annual Report was prepared consistent with the requirements of Section 3.6.2 of the SMP, Revision 7 (Ramboll 2022a) to summarize and evaluate the results of the inspection, maintenance, and monitoring activities and to document the continued adequacy of the implemented risk management measures at the Site.

The SMP was initially submitted to NDEP in April 2012. On May 23, 2012 and May 30, 2012, errata were submitted to address NDEP's May 14, 2012 comments. The April 2012 SMP and two errata letters (ENVIRON 2012; hereafter referred to as the SMP, Revision 0) were approved by NDEP on June 1, 2012. The Trust has updated the SMP as follows to accurately reflect Site conditions and comply with the document's update requirement¹:

- SMP, Revision 1 dated October 2013 (ENVIRON 2013), which was approved by NDEP on November 7, 2013;
- SMP, Revision 2 dated July 17, 2015 (Ramboll Environ 2015), which was approved by NDEP on August 8, 2015;
- SMP, Revision 3 dated February 13, 2017 (Ramboll Environ 2017), which was approved by NDEP on February 28, 2017;
- SMP, Revision 4 dated March 22, 2018 (Ramboll 2018), which was approved by NDEP on March 29, 2018;
- SMP, Revision 5 dated December 31, 2019 (Ramboll 2019), which was approved by NDEP on January 21, 2020;
- SMP, Revision 6 dated December 22, 2020 (Ramboll 2020), which was approved by NDEP on January 6, 2021; and

- SMP, Revision 7 dated January 12, 2022 (Ramboll 2022a), which was approved by NDEP on January 26, 2022.

During the current annual reporting period (June 1, 2021 through May 31, 2022), SMP, Revision 6 was effective between June 1, 2021 and January 25, 2022 and SMP, Revision 7 was effective between January 26, 2022 and May 31, 2022.

As required by SMP Revisions 6 and 7, this Annual Report provides the following:

- A summary of the results of the inspection, maintenance, and monitoring of the risk management measures that are implemented through the SMP;
- Documentation of compliance with the SMP including submittal of required notifications and utilization of appropriate protocols for subsurface activities that were implemented;
- Documentation of any instances of noncompliance with the SMP and the actions taken to remedy the issues; and
- Recording any changes to each Excavation Control Area (ECA) boundary, based on work conducted during the reporting period.

Inspection, Maintenance, and Monitoring Activities and Implemented Risk Management Measures

An evaluation of the results of the inspection, maintenance, and monitoring activities and the adequacy of the risk management measures during the period of June 1, 2021 through May 31, 2022 is provided below.

- The Site's land uses were confirmed to be consistent with those assumed in the SMP (i.e., industrial/commercial) in terms of exposure risk assumptions.
- There were no significant changes in land use or COPC toxicity parameters that warranted conducting additional risk analysis or additional mitigation.
- Table 1 in both SMP, Revisions 6 and 7 reflect the most current Basic Comparison Levels (BCLs) dated July 2017 (NDEP 2017) for the majority of the reporting period.²
- Groundwater was not used for drinking water at the Site.
- No changes to ECA boundaries were made based on work conducted during the evaluation period.
- The groundwater monitoring data evaluated in the Annual Groundwater Monitoring and GWETS Performance Report (Ramboll 2022b) indicated that there were no significant changes in Site environmental conditions that require modification of the SMP; and
- On behalf of the Trust, Ramboll and Tetra Tech inspected the Site as necessary and verified that the SMP-required risk management controls are being implemented at the Site.

SMP Compliance

Upon NDEP approval of the SMP, Revision 7 on January 26, 2022, all Site Occupants were provided a copy of the SMP and notified of the known environmental conditions at the Site and the requirements of the SMP. Each Site Occupant certified that it would comply with the provisions in the SMP, Revision 7. The Certifications of Compliance (included as Requirement 1 of the SMP, Revision 7) for all Site Occupants are included as Attachment B of this letter. All Site Occupants had previously certified their compliance with the provisions of

SMP, Revision 6 following its approval by NDEP. Those Certifications of Compliance were included in the 2020-2021 SMP Annual Report.

NERT certifies that all Site disturbances were conducted in compliance with the SMP including the appropriate notifications and with the appropriate protocols for subsurface activities.

Summary

The evaluation of the results of the inspection, maintenance, and monitoring activities and the continued adequacy of the implemented risk management measures at the Site during the Annual Review period indicate that all Site disturbances have been conducted in compliance with the SMP.
