Logistical Solutions (LoSo) is pleased to provide ENVIRON International Corporation this *Letter Report for Final Visual Inspection of the RZ-E Soil Stockpile Area* conducted for the Nevada Environmental Response Trust site located at 560 West Lake Mead Parkway in Henderson, Nevada. The purpose of the final visual inspection was to identify, within reason, the presence and location of potential asbestos- containing materials (ACMs) that were stockpiled within a regulated control zone located on and adjacent to Remediation Zones RZ-D-30 and RZ-D-31 (project area).

On June 20, 2011 through June 23, 2011, Earth Resource Group excavated soil and concrete pipe material from several Beta Ditch culverts until no visual evidence ACM was encountered. The materials excavated from these areas were stockpiled within a regulated control zone located on and adjacent to RZ-D-30 and RZ-D-31. The stockpile was subsequently removed on the evening of June 23, 2011 into June 24, 2011. The attached site plan depicts the general location of the stockpile control area.

## Visual Site Inspection

On June 24, 2011, Mr. Kristopher Everett of LoSo was contacted by Steve Schafer of Earth Resource Group to conduct a final visual clearance inspection of the regulated asbestos zone. Mr. Everett performed a visual inspection on the same day he was contacted by Mr. Schafer of the regulated asbestos zone. The regulated asbestos zone was assessed for signs of visible ACM debris. Asbestos and/or asbestos containing debris were not observed during the inspection of the regulated asbestos zone.

The visual inspection was conducted in a manner consistent with the recommendations specified in the American Society for Testing and Materials (ASTM) E1368-05<sup> $\varepsilon$ 1</sup> standard. This report applies only to the subject areas at the time of our inspection.

## **Limitations**

This report has been prepared for the exclusive use of ENVIRON International Corporation, as it applies to the subject regulated asbestos zone at the project area.
