The Nevada Environmental Response Trust (NERT) has received the Nevada Division of Environmental Protection's (NDEP's) comments dated March 9, 2022 regarding the Baseline Health Risk Assessment (BHRA) Report for Operable Unit 1 (OU-1) Soil Gas and Groundwater. As previously discussed with NDEP, NERT proposes the following path forward to address NDEP's comments and prepare a revised report for NDEP's review.

1. NERT will prepare an annotated response to comments and submit to NDEP for review by June 24, 2022.
2. NERT will work with NDEP to agree upon the resolution of each of NDEP's comments. Upon reaching agreement on resolution of NDEP's comments, NERT will prepare a budget amendment, if necessary as defined in footnote 48 of NERT's 2022 annual budget, and schedule to prepare the revised BHRA Report for OU-1 Soil Gas and Groundwater.
3. Upon approval of NERT's budget amendment, if necessary, NERT will prepare the revised BHRA Report for OU-1 Soil Gas and Groundwater and submit it in accordance with the approved schedule.

NERT believes that this process will yield a revised report that addresses NDEP's comments and provides the supporting documentation to prepare the forthcoming Feasibility Study for OU-1 and OU-1 in a cost effective and expeditious manner.
