Subject: Tronox LLC ECA Quarterly Activity Report – Third Quarter 2008

Pursuant to Section XIII of the Consent Agreement, signed September 5, 1996, between Nevada Division of Environmental Protection (NDEP) and Tronox LLC (Tronox), we submit the following quarterly status report for the Henderson facility's Environmental Conditions Assessment (ECA).

Activities Conducted: 07-01-08 to 09-30-08

Conceptual Site Model:

- August 4 2008 NDEP provided comments on Tronox's Proposed Hydrostratigraphic Nomenclature BMI Complex and Common Areas, dated June 27, 2008.
- September 29, 2008 Tronox responded to the NDEP comments on hydrostratigraphic nomenclature.
- Tronox developed three block diagrams for use in the capture evaluation which will support the CSM.

Upgradient Investigation Results:
