SUBJECT: Third Quarter 2010 DMR – Permit # NEV2001516

Tronox LLC (Tronox) maintains a Permit # NEV2001516 covering synthetically lined pond operation in Henderson, Nevada. While there was no discharge to receiving waters from the covered ponds, the attached Discharge Monitoring Reports, DMR's, (Attachment 1) and accompanying tables provide operational information.

In the first and second quarters of 2009, several minor leaks were discovered in the top (primary) liner of the WC-E pond. Liner repairs were completed in the fourth quarter and the pond was put back in service. On February 16th, 2010, the WC-E pond leak detection system discovered a new leak in the top pond liner, as the pond level was increased. This leak has since been evaluated, the pond level has been lowered below the suspected leak area and liner repairs are tentatively scheduled to take place in the month of November.
