## Task Progress Update: September 2021

### Task M26 – Hydrogen-Based Gas Permeable Membrane Pilot Study

- Current Status
  - The pilot study operations were completed on August 9, 2021.
  - In September, decommissioning tasks were completed, including cleaning of influent tanks, disconnection of piping and recirculation of cleaning solution through the system.
- Schedule and Progress Updates
  - The final cleaning and decommissioning of the pilot system is scheduled to be completed during October 2021.
- Health and Safety
  - There were no health and safety incidents related to Task M26 during September 2021.




